**INVITATION TO BID**

**PROCUREMENT OF SECURITY SERVICES**


1. The **Senate Electoral Tribunal (SET)** and **House of Representatives Electoral Tribunal (HRET)**, through the Agencies' Current Appropriations, intend to apply the sum of **Two Million Eight Hundred Thousand Pesos (PhP 2,800,000.00)**, being the Approved Budget for the Contract (ABC) for Fiscal Year 2017, to payments under the contract for the Procurement of Security Services. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The SET and HRET now invite bids for the Security Services composed of eight (8) guards for a period of three years. Duration of service is from January 1, 2017 to December 31, 2019. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in "Section II. Instructions to Bidders".
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from the **SET & HRET Joint Bids and Awards Committee (SET & HRET JBAC)** and inspect the Bidding Documents at the address given below from **24 August 2016 to 02 October 2016, Monday to Thursday at 7:30 a.m. to 5:30 p.m..**

A complete set of Bidding Documents may be purchased by interested Bidders from **24 August 2016 to 02 October 2016** from the address below at a nonrefundable fee of **Five Thousand Pesos (PhP 5,000.00)**.

The Bid Documents may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS) at [www.philgeps.gov.ph](http://www.philgeps.gov.ph), Senate Electoral Tribunal at [www.set.gov.ph](http://www.set.gov.ph) and the House of Representatives Electoral Tribunal at [www.hret.gov.ph](http://www.hret.gov.ph), provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The SET & HRET JBAC will hold a **Pre-Bid Conference** on **21 September 2016, 10:00 a.m.**, at the SET Conference Room, Ground Floor, Electoral Tribunals Building, COA Compound, Batasan Road, Batasan Hills, Quezon City which shall be open only to parties who have purchased Bidding Documents.
6. Bids must be delivered to the address below on or before **03 October 2016, 09:45 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.  
  
Bid opening shall be on **03 October 2016, 10:00 a.m.**, at the SET Conference Room, Ground Floor, Electoral Tribunals Building, COA Compound, Batasan Road, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
7. The SET & HRET reserve the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
