RENOVATION CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This Contract was made and entered into by and between:

The SENATE ELECTORAL TRIBUNAL (SET), an instrumentality of the Republic of the Philippines, created and existing under the Constitution, represented by its Chairperson, Honorable Justice ANTONIO T. CARPIO, hereinafter referred to as the TRIBUNAL;

-and -

LOURBEL CONSTRUCTION AND SUPPLY, a building contractor duly organized and existing under the laws of the Philippines, with principal address at Pag-asa Rawis, Legaspi City, Albay, represented herein by its Proprietress and Manager, Ms. LOURDES M. BELTRAN, hereinafter referred to as the LOURBEL;

WITNESSETH THAT:

WHEREAS, the Tribunal requires the services of a reliable and competent contractor that will undertake the renovation of the electrical system of its offices (Rooms 101-102 and the Left Wing of the Electoral Tribunals Building) located at the Commission on Audit Compound, corner Batasan Road and Commonwealth Avenue, Quezon City;

WHEREAS, REPUBLIC ACT NO. 9184, otherwise known as the GOVERNMENT PROCUREMENT REFORM ACT, provides in Section 10 thereof that all procurement shall be done through Competitive Bidding;

WHEREAS, pursuant to the foregoing provision and the REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. NO. 9184, the Senate Electoral Tribunal Bids and Awards Committee conducted a public bidding for the procurement of a Contract for the Renovation of the Electrical System of the Senate Electoral Tribunal Offices, hereinafter called THE RENOVATION;

WHEREAS, the Senate Electoral Tribunal Bids and Awards Committee, after a thorough examination and evaluation of pre-qualified bidders, determined that the bid of LOURBEL at Five Million Nine Hundred Fifteen Thousand Nine Hundred Ninety and 50/100 Pesos (P5,915,990.50) for the execution and completion of THE RENOVATION and the rectification of any defects is the Lowest Calculated Responsive Bid; and, recommended that the contract for the THE RENOVATION be awarded to LOURBEL;

WHEREAS, pursuant to such recommendation, the Chairperson of the TRIBUNAL awarded the contract for THE RENOVATION to LOURBEL;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties do hereby agree on the following terms and conditions:

 In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of Contract referred to hereunder.

 - (k) Notice of Award of Contract and the Bidder's Conforme thereto;

- In consideration of the payments to be made by the TRIBUNAL to LOURBEL as hereinafter mentioned, LOURBEL hereby covenants with the TRIBUNAL to execute and complete THE RENOVATION and rectify any defects therein in conformity with the provisions of this Contract.
- 4. In case of default by LOURBEL, nothing in this contract or in any of its attachments may be construed as a waiver, express or implied, on the part of TRIBUNAL of any rights or remedies allowed by existing laws including but not limited to suspension of work or recovery of liquidated damages. The TRIBUNAL may, at its option, exercise any or all of said rights or remedies to protect the interest of the government.
- 5. The TRIBUNAL hereby covenants to pay LOURBEL in consideration of the execution and completion of THE RENOVATION and the rectification of defects therein, Five Million Nine Hundred Fifteen Thousand Nine Hundred Ninety and 50/100 Pesos (P5,915,990.50) or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed in this Contract.
