RESOLUTION NO. 15-03

The Senate Electoral Tribunall Resolves to CONFIRM the following Resolutions issued by the Executive Committee:

- a) Resolution No. 01-15 dated 10 August 2015, requiring Petitioner David to correct the formal defects in his petition, within a non-extendible period of three (3) days from receipt of the Resolution by:
 - Stating the date of the proclamation of the Respondent Mary Grace Poe Llamanzares as senator-elect of the Philippines;
 - 2) Stating the correct date of the petition;
 - Observing the requirements of Section 4, Administrative Matter No. 1109-4-SC (Efficient Use of Paper Rule) on margins and consecutive numbering of every page of the petition;
 - 4) Submitting complete copies of Annex "C" of the petition; and
 - 5) Ensuring that the pages of the petition are correctly collated;

and

b) Resolution No. 15-02 dated 18 August 2015,

- 1) NOTING the Amended Petition filed on 17 August 2015 by Petitioner Rizalito Y. David, through counsel, in compliance with the Resolution of the Executive Committee dated 10 August 2015;
- 2) DIRECTING the Secretary of the Tribunal to issue the corresponding summons to Respondent Mary Grace Poe Llamanzares, requiring her to file her ANSWER to the Amended Petition within a nonextendible period of ten (10) days from receipt of the summons; and
- 3) NOTING the entry of appearance of Atty. Manuelito R. Luna as counsel for Petitioner David and providing that copies of resolutions, orders and notices of the Tribunal be served upon him at his office address at the Luna Law Office, Room 421, FEMII Building Annex A, Soriano, Jr. Avenue, Intramuros, Manila, Philippines.
