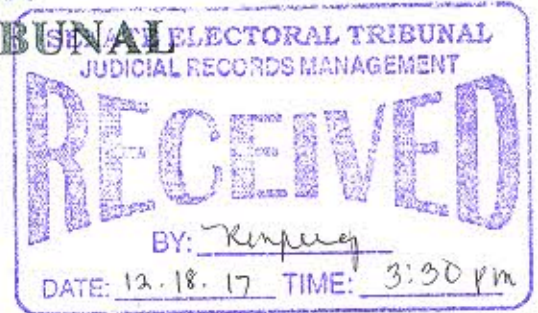

RESOLUTION NO. 16-86

The Tribunal, in Resolution No. 16-83 dated 22 November 2017, requested the Commission on Elections to shed light within fifteen (15) days from receipt thereof on why the Ballot IDs for Clustered Precincts Nos. 4 and 6 of San Jorge, Western Samar differ from the COMELEC-assigned ballot IDs.

The COMELEC filed on 11 December 2017 a *Motion for Extension to File Compliance* stating therein that a copy of said Resolution was received on 27 November 2017 and that compliance is due on 12 December 2017. COMELEC further stated that its Law Department has coordinated the matter with the Printing Committee in charge of the 09 May 2016 National and Local Elections and that the said Committee is still in the process of checking the records. In view thereof, the Commission prays for an additional period of fifteen (15) days from 12 December 2017 or until 27 December 2017 to comply with the abovementioned Resolution.

ACTING on the COMELEC *Motion*, the Executive Committee of the Tribunal Resolves to **GRANT** the Commission on Elections additional period of fifteen (15) days or until 27 December 2017 within which to file its Compliance with Resolution No. 16-83 dated 22 November 2017.
