RESOLUTION NO. 05

WHEREAS, the Senate Electoral Tribunal (SET), through its budget in the General Appropriations Act 2023, intends to apply the sum of Three Hundred Fifty Thousand Pesos (Php350,000.00), being the Approved Budget for the Contract, for the procurement of Periodic Maintenance Service (PMS) of Service Vehicles;

WHEREAS, for the above procurement project, the SET Bids and Awards Committee (BAC) resorted to Negotiated Procurement-Small Value Procurement pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the BAC, through the BAC Secretariat, posted copies of the Request for Quotation on the PhilGEPS website, SET official website, and SET Bulletin Board for a period of nine (9) days from 2 February to 10 February 2023;


WHEREAS, the BAC, through the BAC Secretariat, sent Requests for Quotation to (1) Toyota North EDSA (Toyota Balintawak Inc.), (2) FleetServ Inc., (3) Toyota Fairview, Inc., and (4) RAKKII Auto Service;

WHEREAS, the BAC Secretariat received quotations before the deadline from (1) Toyota North EDSA (Toyota Balintawak Inc.), (2) Toyota Fairview, Inc., and (3) FleetServ Inc.;

WHEREAS, after the evaluation of the submitted quotations, Toyota North EDSA (Toyota Balintawak Inc.) is found to be compliant with all the requirements and technical specifications of the SET, and is thus determined as having submitted the Lowest Calculated and Responsive Quotation (see Abstract of Quotation);

WHEREFORE, the Senate Electoral Tribunal Bids and Awards Committee hereby resolves to recommend the award of the Contract for the procurement of Periodic Maintenance Service (PMS) of Service Vehicles to Toyota North EDSA (Toyota Balintawak Inc.) for the total contract price of One Hundred Ten Thousand One Hundred Forty-Two Pesos and 13/100 (Php110,142.13).


