**RESOLUTION NO. 24**  
**Series of 2023**

**WHEREAS**, the Senate Electoral Tribunal (SET), through its budget in the General Appropriations Act 2022 (Continuing Appropriations), intends to apply the sum of Two Million Five Hundred Thousand Pesos (Php2,500,000.00) being the Approved Budget for the Contract, to payments under the contract for the Supply and Delivery of One (1) Brand New Passenger Van under Project ID No. 2023-08-001;

**WHEREAS**, for the above procurement project, the SET Bids and Awards Committee (BAC) resorted to competitive bidding pursuant to Section 10, Article IV of Republic Act No. 9184, otherwise known as "The Government Procurement Reform Act";

**WHEREAS**, the BAC posted the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS) website, the SET website, and on bulletin boards at the SET premises continuously for twenty (26) days from 10 August to 4 September 2023;

**WHEREAS**, one (1) prospective bidder attended the Pre-bid Conference on 22 August 2023, namely, Prince Motor Corporation;

**WHEREAS**, only one (1) bidder, Prince Motor Corporation, purchased the bidding documents and submitted a bid on 4 September 2023;

**WHEREAS**, during the scheduled opening of bids on 4 September 2023, Prince Motor Corporation was found to have submitted all the legal, technical and financial requirements;

**WHEREAS**, after the bid evaluation on 5 September 2023, Prince Motor Corporation was declared the sole bidder with the Single Calculated Bid (SCB) in the amount of Two Million One Hundred Seventy-One Thousand Eight Hundred Pesos (Php2,171,800.00);


**WHEREAS**, on 11 September 2023, upon validation and verification of all the legal, technical, and financial requirements, as well as the additional documentary requirements, the bid of Prince Motor Corporation was found to be responsive, and thus post-qualified;


**WHEREFORE**, the Senate Electoral Tribunal Bids and Awards Committee hereby **RESOLVES**:


- a. To declare the bid of Prince Motor Corporation as the Single Calculated and Responsive Bid (SCRB); and


- b. To recommend the award of the contract for the Supply and Delivery of One (1) Brand New Passenger Van to Prince Motor Corporation in the amount of Two Million One Hundred Seventy-One Thousand Eight Hundred Pesos (Php2,171,800.00).
