**RESOLUTION NO. 46**  
**Series of 2023**

**WHEREAS**, the Senate Electoral Tribunal (SET), through its budget in the General Appropriations Act 2024, intends to apply the sum of Two Million Two Hundred Seventy-Four Thousand Pesos (Php2,274,000.00) being the Approved Budget for the Contract, to payments under the contract for the Supply and Delivery of Janitorial Services for FY 2024 under Project ID No. 2023-11-003;

**WHEREAS**, for the above procurement project, the SET Bids and Awards Committee (BAC) resorted to competitive bidding pursuant to Section 10, Article IV of Republic Act No. 9184, otherwise known as "The Government Procurement Reform Act";

**WHEREAS**, the BAC posted the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS) website, the SET website, and on bulletin boards at the SET premises continuously for twenty-one (21) days from 15 November to 05 December 2023;

**WHEREAS**, two (2) prospective bidders attended the Pre-bid Conference on 22 November 2023, namely: D' Triumph Cleaners and Allied Services, Inc. and CMPT Manpower Services;

**WHEREAS**, two (2) bidders, namely: D' Triumph Cleaners and Allied Services, Inc. and CMPT Manpower Services purchased the bidding documents and submitted their respective bids on 05 December 2023;

**WHEREAS**, during the scheduled opening of bids on 05 December 2023, the bid proposals of D' Triumph Cleaners and Allied Services, Inc. and CMPT Manpower Services were found to comply with all the legal, technical, and financial requirements;

**WHEREAS**, the bids of the two bidders, as read, are as follows:

**WHEREAS**, after the bid evaluation on 06 December 2023, the bid proposal of D' Triumph Cleaners and Allied Services, Inc. was declared the Lowest Calculated Bid (SCB) in the amount of One Million Nine Hundred Eighty-Seven Thousand Two Hundred Pesos (Php1,987,200.00);

**WHEREAS**, on 11 December 2023, upon validation and verification of all the legal, technical, and financial requirements, as well as the additional documentary requirements, the bid of D' Triumph Cleaners and Allied Services, Inc. was found to be responsive, and thus post-qualified;


**WHEREFORE**, the Senate Electoral Tribunal Bids and Awards Committee hereby **RESOLVES**:


- a. To declare the bid of D' Triumph Cleaners and Allied Services, Inc. as the Lowest Calculated and Responsive Bid (SCRB); and
