## RESOLUTION NO. 45 Series of 2023

WHEREAS, the Senate Electoral Tribunal (SET), through its budget in the General Appropriations Act 2024, intends to apply the sum of Two Million Seven Hundred Eighty-Nine Thousand Pesos (Php2,789,000.00) being the Approved Budget for the Contract, to payments under the contract for the Supply and Delivery of Security Services for FY 2024 under Project ID No. 2023-11-002;

**WHEREAS,** for the above procurement project, the SET Bids and Awards Committee (BAC) resorted to competitive bidding pursuant to Section 10, Article IV of Republic Act No. 9184, otherwise known as "The Government Procurement Reform Act";

WHEREAS, the BAC posted the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS) website, the SET website, and on bulletin boards at the SET premises continuously for twenty-one (21) days from 15 November to 05 December 2023;

**WHEREAS**, two (2) prospective bidders attended the Pre-bid Conference on 22 November 2023, namely: Maximum Security & Services Corporation and Dark Horse Security Agency, Inc.;

**WHEREAS**, only one (1) bidder, Maximum Security & Services Corporation, purchased the bidding documents and submitted a bid on 05 December 2023;

WHEREAS, during the scheduled opening of bids on 05 December 2023, Maximum Security & Services Corporation was found to have submitted all the legal, technical, and financial requirements;

**WHEREAS**, after the bid evaluation on 06 December 2023, Maximum Security & Services Corporation was declared the sole bidder with the Single Calculated Bid (SCB) in the amount of Two Million Six Hundred Fifty-Four Thousand Four Hundred Seventy-Two Pesos and 36/100 (Php2,654,472.36);

WHEREAS, on 11 December 2023, upon validation and verification of all the legal, technical, and financial requirements, as well as the additional documentary requirements, the bid of Maximum Security & Services Corporation was found to be responsive, and thus post-qualified;

WHEREFORE, the Senate Electoral Tribunal Bids and Awards Committee hereby RESOLVES:

a. To declare the bid of Maximum Security & Services Corporation as the Single Calculated and Responsive Bid (SCRB); and

b. To recommend the award of the contract for the Supply and Delivery of Security Services for FY 2024 to Maximum Security & Services Corporation in the amount of Two Million Six Hundred Fifty-Four Thousand Four Hundred Seventy-Two Pesos and 36/100 (Php2,654,472.36).
