**RESOLUTION NO. 15-09**

The Tribunal Resolved to **CONFIRM** the following resolutions and order issued by the Executive Committee:

- 1) **Resolution No. 15-04 dated 26 August 2015,**

**NOTING** the entry of appearance of the Poblador Bautista & Reyes Law Firm as counsel for Respondent Poe Llamanzares and **DIRECTING** that copies of all orders, resolutions and other issuances of the Tribunal, as well as all pleadings, submissions and other communications from Petitioner be furnished said counsel at its given address; and

**GRANTING** the *Motion to Subpoena BID'S Record of Application of Citizenship Re-Acquisition and Related Documents, Including the Record of Travels of Respondent Mary Grace Poe Llamanzares and NSO-Kept Birth Certificate of Same Person* filed by counsel for Petitioner David and **DIRECTING** the Secretary of the Tribunal to issue the corresponding subpoenas to the respective officials of the Bureau of Immigration and the National Statistics Office having official custody of the documents requested, commanding them to appear at the Office of the Secretary, Senate Electoral Tribunal on 01 September 2015 at 10:00 a.m. and to bring and produce three (3) set of the documents requested;

2) **Resolution No. 15-05 dated 02 September 2015,**

**REQUIRING** the parties and their respective counsel to appear before the Tribunal at the preliminary conference to be held on Friday, 11 September 2015, at the Supreme Court En Banc Conference Room, 2<sup>nd</sup> Floor, Supreme Court Building I, Padre Faura, Manila at 10:00 o'clock in the morning; and to file with the Tribunal not later than Wednesday, 09 September 2015, in fifteen (15) legible copies and serve on the adverse party, both through personal service, a preliminary conference brief containing the matters enumerated in the resolution;

3) **Resolution No. 15-06 dated 07 September 2015,**

**NOTING** the entry of appearance of the G.E. Garcia Law Office as collaborating counsel for Respondent Poe Llamanzares and **DENYING** the request of G.E. Garcia Law Office that it be furnished copies of all writs, orders and processes of the Tribuna; and

**NOTING** the *Manifestation* dated 02 September 2015 filed by counsel for Respondent Poe-Llamanzares.

4) **Preliminary Conference Order dated 14 September 2015;** and

5) **Resolution No. 15-08 dated 27 October 2015,**

**GRANTING** the *Motion for Leave for Extension* filed by counsel for Respondent Poe-Llamanzares, seeking an extension of fifteen (15) days from 21 October 2015, or until 05 November 2015, within which to submit the DNA Test results.


