### RESOLUTION NO. 08 Series of 2024

WHEREAS, the Senate Electoral Tribunal (SET), through its budget in the General Appropriations Act 2024, intends to apply the sum of Two Hundred Sixty Thousand Pesos (Php260,000.00), being the Approved Budget for the Contract, for the Rental of Two (2) Units of Air-conditioned Buses;

WHEREAS, for the above procurement project, the SET Bids and Awards Committee (BAC) resorted to Negotiated Procurement-Small Value Procurement pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the BAC, through the BAC Secretariat, posted copies of the Request for Quotation on the Philippine Government Electronic Procurement System (PhilGEPS) website, SET official website, and SET Bulletin Board for a period of six (6) days from 21 February to 26 February 2024;

WHEREAS, the BAC, through the BAC Secretariat, sent Requests for Quotation to (1) Coda Lines (CLC) Corp., (2) Ohayami Trans, (3) Circle Transport Corporation, and (4) Roma Tours & Transport Inc.;

**WHEREAS,** the BAC Secretariat received quotations from (1) Coda Lines (CLC) Corp., (2) Ohayami Trans, and (3) Circle Transport Corporation;

WHEREAS, after the evaluation of the submitted quotations, Coda Lines (CLC) Corp. is found to be compliant with all the requirements and technical specifications of the SET, and is thus determined as having submitted the Lowest Calculated and Responsive Quotation (see Abstract of Quotation);

WHEREFORE, the Senate Electoral Tribunal Bids and Awards Committee hereby resolves to recommend the award of the Contract for the Rental of Two (2) Units of Air-conditioned Buses to Coda Lines (CLC) Corp. for the total contract price of Two Hundred Ten Thousand Four Hundred Pesos (Php210,400.00).
